“Context is everything”

THE POLITICS OF MAN

“Government being instituted for the common benefit, protection, and security, of the whole community, and not for the private interest or emolument of any one man, family, or class of men; therefore, whenever the ends of government are perverted, and public liberty manifestly endangered, and all other means of redress are ineffectual, the people may, and of right ought to reform the old, or establish a new government. The doctrine of non-resistance against arbitrary power, and oppression, is absurd, slavish, and destructive of the good and happiness of mankind.

What is happening in Australia is, globally, being described as medical totalitarianism. Even New Yorkers were so shocked by events “down under” that they spontaneously marched through their city to support the Aussies.

What we regard as the illegal position adopted by NT Chief Medical Officer Hugh Crosbie Heggie, thereby enabling population repression by the Gunner Government.

“I Hugh Crosbie Heggie, Chief Health Officer, under section 52 of the Public and Environmental Health Act 2011 (the Act), consider it **necessary, appropriate or desirable to take action to alleviate the public health emergency in the Territory, declared by instrument entitled “Declaration of Public Health Emergency”, dated 18 March 2020, (the public health emergency declaration), by making the following directions.”**

Note: How can the words **appropriate** and **desirable** be actively incorporated in a declaration that overrides the Australian Constitution? How is this not contempt for the Australian legal system?

The Northern Territory synopsis and context

Thousands of intelligent and well-informed Territorians protest to Parliament every week. They reject the illegal and unconstitutional mRNA mandate and demand that the Gunner Government rescind the order or step down.

The CLP has been alerted to its prospective response to restore legal government. If it fails, a coalition of small political parties is ready to step into the breach, with or without CLP leadership. Numerically, small parties have a higher membership than the LNP and ALP combined.

The First Nation component of the NT population has a different and aggregate overview, recognising instead what it regards as fundamental betrayals with a collective genesis in:

- The abandonment of the Policy of Self Determination;
- The entirely unjustified Intervention;
- ALP approval of fracking despite an electoral promise to not proceed.
- The use of bribery and blackmail to submit to an unwanted jab.

First nations people are currently planning their own rebellion, in tandem with the Mainstream population. Interestingly, the most articulate call to arms flows from the Byron Bay region. This is a first national unification on any Aboriginal issue.

Meanwhile, the Federal Government, anticipating such legal and uncontrollable rebellion, and aware that army personnel have already declared their preparedness to shoot their officers if ordered to open fire on civilians, has launched a **Bill (“Defence Legislation Amendment (Enhancement of Defence Force response to Emergencies) Bill, 2020”; Clause 123AA)** to enable foreign troops to enter Australia and to enforce mandates by whatever means necessary, and if this incorporates death and injury, the foreign troops are immune from prosecution. Chillingly, Indonesia’s notorious **Kopassus Shock Troops** are already in the Top End, training how to knock doors down and kill “recalcitrant” Australians.

Countering this, are Special Services soldiers who also refuse to submit to an illegal and unwanted mandate and these personnel support the protestors and have, in fact, convened the **AustraliaOneParty** under the leadership of much-admired Riccardo Bosi.

This is clearly the threshold to civil war.

There is only one way national catastrophe can be averted and that is for an NT Judge to rule the mRNA mandate illegal and unconstitutional, and also to declare the use of Ivermectin and HCQ legal.

The Nebraska decision (covered below) is a useful precedent albeit of a foreign jurisdiction; as are the Uttar Pradesh and Goa experiences.

We appreciate that no judge would want to be placed in this position, yet history has set the stage and each of us must perform our parts with courage and conviction.

If the **Rule of Law is restored in the NT**, the states and ACT will follow suit.

LAWS CONTRAVENED

Australian Constitution: Section 51 23A was mandated by national referendum in 1946, a rare manifestation of pure democracy. It is the most popular socio-legal interpretation in Australia that the constitutional amendment (Sec 51 23A), mandated as it was by national referendum, **can only be varied if mandated by a countering referendum**. To interpret otherwise denies the entire function of referenda in a democracy.

As far as we are aware, there has been no defining legal ruling on this, at least until now. **We believe such a ruling is now critical to prevent the kind of ruthless political manoeuvring we have become used to in recent decades.**

The Privacy Act (1988). Recent amendments to this act are also in breach of the Constitution, and completely overturn the essential purpose of the Privacy Act.

Police and the Courts have been heavy-handed in dealing with protestors yet political protest is in fact a protected right under **Section 83:4 of the Commonwealth Criminal Code Act 1995** and to hinder the exercise of a political right or duty is a criminal act in itself.

Because heavy repression is clearly on the agendas of both the NT and Commonwealth Governments, we consider that **reassertion of citizen's rights must be integral to this judgement.**

My position of legal challenge:

Covid-19 disease has a recovery rate of 99.97% and cannot be described as an emergency. Moreover, even if it was, Heggie cannot overrule the **Australian Constitution: Section 51 23A.**

Ergo, **forced medical intervention** is assault, and **public conscription** is proscribed. Moreover, forced or coerced medical intervention **violates the Nuremberg Code**, to which Australia subscribed with intense self-righteousness. Heggie must publicly reject both the Constitution and Nuremberg Code and face the legal and political consequences, **or rescind orders under the Public Health and Environment Act.**

Additionally, Heggie must respond to the evidence from the Indian state of Uttar Pradesh that undeniably demonstrates **Ivermectin Triple Therapy both protects against Covid-19 infection, and successfully treats those thus infected.**

Heggie must also acknowledge the evidence from Israel and other nations with high mRNA vaccination rates, **that this treatment damages the recipient's immune systems, making them fatally vulnerable to Antibody Dependent Enhancement (ADE).** Heggie, in absolute defiance of scientific evidence, claims this is caused by the unvaccinated. Absurd deflection has now become outright lies.

BROADER RAMIFICATIONS

Edicts, interpretations, and rulings on covid-19 containment measures, medical interventions; and, as cascading requirements, PCR tests and use of the dangerous drug Remdesivir, are challenged on the basis of violation of Section 51 23A of the Australian Constitution, and are manifestly in violation of the Nuremberg Code, to which Australia is party.

The Nuremberg Code outlaws experimental medical interventions without securing informed consent of the recipients. As we saw in 1947, this is a crime punishable by death. (For the full Code, see page 24).

Because I believe healthy self-interest is a great motivator, may I also observe that the medical totalitarianism into which Australia is descending, means that in the not-too-distant future, guilt of crime will be decided by generic decree; property will no longer be owned or sold, thus eliminating conveyancing; and laws will be unnecessary because all government action will be by decree.

This means lawyers will shortly be obsolete.

Anybody sceptical of this assertion is referred to the recent *World Economic Forum* speech of convenor Klaus Schwab, with echoes of support from various elite investment banker dynasties and plutocrats. Among these are the Rockefellers, Rothschilds, Pirbright Institute, Tavistock Institute, Trilateral Commission, Wellcome Institute, Henry Kissinger, George Soros, Bill Gates, Mark Zuckerberg, and Anthony Fauci. History confirms this anticipation, as readers of the German and Italian legal experience under Naziism and Fascism testified so bitterly.

This challenge to legality mounted by ordinary Territory citizen Mr Tony Ryan is reinforced by superior medical recommendations provided by global scientific experts who categorically and generically condemn Heggie's containment measures and conclusions.

Briefly, these (named on page ten) experts are unanimous in their determination that:

- Covid-19 is as significant as a bad case of flu, even milder as an outcome of ongoing mutations.
- National death rates have not risen appreciably, demonstrating that "covid deaths" have been fraudulently inflated;
- The global recovery rate is 99.97% and therefore is manifestly not "dangerous" as proclaimed;
- That actual Covid deaths were sustained by those who were obese, diabetic, or otherwise dying;
- The PCR test is unsuited to diagnosis of covid and it is outrageously misused; according to its inventor.
- Face masks possess air passages that are 1000 times larger than the virus and are therefore useless in preventing transmission;
- Use of face masks has generated a pandemic of bacterial pneumonia;
- Use of face masks has caused a 25% reduction in oxygen inhalation in small children thus injuring their brain and other development;
- The mRNA injection is not a vaccination, but a genetic intervention which causes cells to become spike protein factories, which then injure endothelial and epithelial membranes of the heart, vascular system, and brain. In 1:1000 young males this causes cardiomyitis, sometimes fatally, and in women, neurological degeneration and spontaneous abortions. There have been numerous cases of anaphylactic shock following the injection.
- It is standard protocol for intramuscular jabs to retract the plunger on a hypodermic syringe to check that a vein or artery has not been hit. Doctors say this is never done with mRNA jabs, which is extremely dangerous and betrays the absence of duty of care.
- Platelets form aggregations (blood clots), red blood cells commence stacking like coins, and D-Dimer tests show that 62% of mRNA recipients develop microscopic blood clots in capillaries. These could eventually cause cell necrosis and, finally, multiple gangrene.
- The lockdowns and threatened mandates have contributed massively to public mental ill-health; the opposite of what health acts are meant to achieve.
- The mandates and lockdowns have seriously damaged the economy, needlessly as it happens.
- The Israeli experience shows the mRNA regime actually increases infections because of the ADE factor, and also increases the serious illness response. The mRNA jab reduces the immune response by 5% per month, which means that within 20 weeks of 2 shots, the fully vaccinated will have zero immune capacity. This means even colds and flu will be dangerous.
- Researchers estimate there have been 1.2 million deaths due to the mRNA jab but, as only 1% of adverse effects are recorded by VAERS, these are 100% underestimated. The official death toll is 12,000, which is still way

above the threshold for ceasing a jab regime. Yet the TGA continues to claim these are safe, even for children.

- Media and political slandering of protestors as mad antivaxxers hides the reality that not one of the medical experts (listed page 10) are anti-vaccination. In fact they are pre-eminent vaccination experts.

In breathtaking contrast, the state of Uttar Pradesh in India, has been using Ivermectin, both as a prophylactic and treatment, and has reduced covid deaths to almost zero in a few months (see attached graph).

Heggie's model of containment was abandoned several months ago. Goa has an identical experience; and central African nations that use HCQ as a routine once-per-week prophylactic against malaria, have virtually no covid infections at all (Tanzania, Burundi, etc).

Ergo, Ivermectin has been used successfully for three decades, has had 63 successful anti-viral trials, is virtually without side effects, and is invariably successful. **Ironically, the designer of the Ivermectin + Zinc + Doxycycline regime (Ivermectin Triple Therapy), is Australia's most famous doctor-scientist, Professor Thomas Borody.** According to rumour, he is under house arrest. What has this country become?

This document is also based on the premise that medical fact is most reasonably identified by the most qualified, most eminent, most admired, and most high-achieving medical scientists on this planet. Contrastingly, medical bureaucrats are invariably bereft of clinical experience and tend towards functional mediocrity. Yet it is these non-performers whose views prevail in Australia.

This is without precedent in government.

Whilst it is acknowledged that legal interpretations and judgements cannot incorporate non-legal issues, I believe it is important to bear in mind the medical reasons for which we enact health laws.

When public understanding of issues is the result of a total public suppression of world expert opinions and evidence, especially when this censorship is imposed by politicians and media owners, there can be no valid health laws.

Currently, doctors are forbidden to prescribe Ivermectin or HCQ and are threatened with deregistration and imprisonment for speaking out against the current covid-containment regime.

It has been accepted for many centuries that laws based on profits for the few, as opposed to protecting public health and welfare, represent bad government and a corrupted legal system. Banning Ivermectin has now been exposed by the Nebraska Attorney General, Doug Peterson, as the outcome of fabricated evidence published by the Lancet, which was later retracted and condemned.

Not insignificantly, we are also guided by the British Bill of Rights, the Magna Carta, and Common Law, upon which our legal system is predicated. Current practice is in conflict with all of these. Even our Police Offences (1914) and Privacy Laws are being breached daily.

Assessing medical opinion impacting on legislation

21

Of critical significance in the delivery of medical advice and subsequent laws, is the absence of monitoring of conflict of interest which, in the medical industry, is marked by funding from commercial influences, such as the pharmacology, radiology, chemical therapy supplier, industries.

Independent medical expertise that we have accessed, adopts the position that Australia's TGA does little or no testing of its own and relies, instead, on data supplied by America's FDA, CDC, and VAERS (Vaccination Adverse Reaction Reporting System).

It is an acknowledged reality in the US that the VAERS system is ignored by 99% of American hospitals and doctors and that vaccine adverse effects and deaths thus recorded represent approximately 1% of actual incidents. US doctors critical of this distortion claim that the official US figure of 14,000 mRNA injection deaths hides a reality closer to 1.2 or 1.4 million deaths, which is clearly not in the realm of "rare events", as claimed by the TGA. (FLCCC, Dr Pierre Cory to the CDC and FDA).

Previously, 30 or so US deaths have resulted in vaccinations being terminated globally (ie the 1976 swine flu vaccination, which resulted in \$4 billion in compensations). Not only is the mRNA injection not being terminated for causing thousands more instances of death, the manufacturers have been provided with total immunity from lawsuit or otherwise demand for compensation. Evidently, this applies also in Australia.

Meanwhile, the criteria for providing medical support for the current injection regime is qualified merely by a medical or pharmacological degree. Less recognised, **is independence from academic peer pressure** or financial incentives, to the tendency of mediocre performers to conform to official dogmas and doctrines which, invariably, act in endemic conflict with academic and scientific independence. Such pressures invariably have their genesis in commercial sources of funding and conditions of employment.

The physical act of the jab itself, is a travesty of medical protocol. An intramuscular jab must avoid injections into veins and arteries, which necessitates a partial plunger pull-back to ensure blood does not enter the cylinder. No injection we have witnessed adopted this essential precaution. Anonymously, doctors have testified that, as the patients will eventually die anyway, hospitals decree that it does not matter if they die immediately of anaphylactic shock or adjuvant toxicity. This is oblique admission of the genocidal intent of the mRNA jab.

Overwhelmingly, Australian doctors are being handsomely rewarded for high vaccination tallies. A bonus of \$80,000 somewhat eliminates objectivity and integrity. Goodbye Hippocrates. Hallo bribery.

But absence of integrity is not confined to the medical arena.

Yet the **Murdoch media** ridicules this as “horse worm medicine”. The **ABC** is not much less muted in its vilification of Ivermectin and truth tellers. The clear extent of complicity in this fraud, and criminal delivery of dangerous medical interventions, is overwhelming.

THE PIVOTAL ISSUE

The mRNA intervention is authorised for public use purely on the condition that no other treatment for Covid-19 is available.

However, the existence of Ivermectin, HCQ, and several other proved-safe drugs and nutritional supplements, renders use of the EXPERIMENTAL mRNA injection absolutely illegal.

Was there testing? Yes, mRNA tested on ferrets a few years ago killed all the ferrets. Fifty rhesus monkeys more recently tested all died. An estimated 1.5 million recipients of the mRNA jab have died.

Testing that qualifies mRNA as safe and as no longer experimental, will take at least eleven more years. Until then, it must remain legally experimental, and can only be used in the total absence of alternative treatments for covid. **This is why Ivermectin and HCQ were banned almost globally, their use invalidating the FDA authorisation.**

The successful use of Ivermectin in India and Brazil threatens a \$96 billion profit.

Hence our “health” laws in Australia. They are there to protect profits and ensure deaths.

Lawyers might well be aware of the very useful corporation titled DEAGLE.

Deagle deals in statistics, mostly for militaries and governments. Their statistics for 2030 show a 65% decline in world population. No explanation is provided. The assessment has since gone offline.

In 2011, an overseas colleague sent me a video interview with Bill Gates, in which he boasted that his vaccines will eliminate 80% of the world’s population. As his “polio vaccines” have paralysed 53,000 Indian children since then, with no concern shown by gates, seems to suggest he is serious in his stated intentions.

He has since boasted of a new virus, which some alarmed virologists believe might be Marburg, which is closely related to Covid-19, but with a death rate of 80%.

IVERMECTIN

As I have observed previously, the most pivotal issue of the mRNA controversy is Ivermectin.

If Ivermectin is proved to be efficacious and safe, the rationale that a *legally and medically experimental* jab can be authorised, collapses entirely, making its use illegal.

Not only does the proved success of Ivermectin render the US FDA/CDC authorisation of experimental medical interventions illegal, it places all parties who participated in this deliberate deception liable to prosecution under the Nuremberg Code.

Following the demand by 4600 doctors and scientists from Europe and the US that Nuremberg be resurrected as Nuremberg II. The leading lawyer/doctor, Reiner Fuellmiche of Germany, has been appointed prosecutor, and referrals for complicity in the mRNA scam are already being forwarded, including the entire TGA, editors and journalists from News Corp media, the ABC, the AMA, individual doctors, chief medical officers, and politicians.

The first European Head of State to authorise extraditions has already withdrawn from the global mRNA campaign (Poland, as I recall).

Ivermectin Wins in India

“News of India’s defeat of the Delta variant should be common knowledge.

Nebraska rules on Ivermectin

Nebraska Attorney General, Doug Peterson Declares ivermectin to be perfectly legal to prescribe. He was scathing of scare-reports that were fabricated.

For example, a paper published in the **Lancet** — one of the most prestigious medical journals in the world, denounced hydroxychloroquine as dangerous, yet the statistics were flawed and the authors refused to provide analysed data.

The [paper was retracted](#), but not before countries stopped using the drug and trials were cancelled or interrupted.

“The Lancet’s own editor-in-chief admitted that the paper was a ‘fabrication,’ a ‘monumental fraud’ and a ‘shocking example of research misconduct’ in the middle of a global health emergency,” **Peterson wrote in the legal opinion.**

Peterson said... “allowing physicians to consider early treatments will free them to evaluate additional tools that could save lives, keep patients out of the hospital and provide relief for our already strained healthcare system”.

The [opinion](#), based on an assessment of relevant scientific literature, was rendered in response to a request by Dianne Smith, CEO of the Nebraska Department of Health and Human Services.

Smith asked the AG’s office to look into whether doctors could face discipline or legal action under [Nebraska’s Uniform Credential Act](#) (UCA) — meant to protect public health, safety and welfare — if they prescribed ivermectin or hydroxychloroquine.

In Darwin, Hugh Heggie has not corrected the media’s (NT News) scripted mantra that Ivermectin (IVM) is a “horse drug”. IVM is one of the safest drugs on the market, having been used on humans for about four decades which extraordinary success – with 3.7 billion prescriptions administered over several decades, and 63 successful trials.

A journal described it thirty years ago... (Japanese) study^[4] published in 2011, entitled “Ivermectin, ‘Wonder drug’ from Japan: the human use perspective” stated in the Abstract, “Discovered in the late-1970s, the pioneering drug ivermectin... has had an immeasurably beneficial impact in improving the lives and welfare of billions of people throughout the world.”

The opening paragraph of the Introduction stated,

“There are few drugs that can seriously lay claim to the title of ‘Wonder drug’, penicillin and aspirin being two that have perhaps had greatest beneficial impact on the health and wellbeing of Mankind. But Ivermectin can also be considered alongside those worthy contenders, based on its versatility, safety and the beneficial impact that it has had, and continues to have, worldwide...” AND “...highly effective and broad-spectrum, safe, well-tolerated...”

As explained by toxicologist Chris Martenson, PhD (Duke), MBA (Cornell) in a video review^[5], that despite the brutal campaign against Ivermectin, a world-class 2021 review paper by Jacques Descotes, a prominent toxicologist working at the behest of Medincell, revealed that **it is among the safest and most well-tolerated drugs ever introduced to the market.**

Ivermectin is well tolerated even at ten times the standard dose of 200 µg/kg,^[6] ^[7]and at high doses, in particular, for COVID-19 treatment.^[8] and ^[9] Cancer

patients who took Ivermectin at five times that standard dose daily for up to 180 consecutive days had no serious adverse effects from it, in experimental protocols with harsh additional drugs.^[10] Of 19 patients who took extreme overdoses up to 1,000-fold that standard dose of either Ivermectin or the closely related Abamectin, all using veterinary forms, only one 72-year-old male who took 440 times the standard dose died.^[11]

Ivmmeta reports that [real-time meta analysis of 63 studies](#) with 26,422 patients, and 623 authors demonstrated that **the use of Ivermectin for COVID-19 was found to have 86% effectiveness in Prophylaxis, 69 – 70% for Early treatment, and 40-43% in Late treatment.**

From the experience of doctors at the ‘front-line’ like [Vladimir Zelenko MD](#), and other front-line doctors, they have found “miraculous” recovery rates using their Ivermectin protocols. Dr Zelenko^[12] has allegedly treated about 7,000 patients and lost 3.

The Nuremberg Code

1. The voluntary consent of the human subject is absolutely essential. This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, over-reaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved, as to enable him to make an understanding and enlightened decision. This latter element requires that, before the acceptance of an affirmative decision by the experimental subject, there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person, which may possibly come from his participation in the experiment. The duty and responsibility for ascertaining the quality of the consent rests upon each individual who initiates, directs or engages in the experiment. It is a personal duty and responsibility which may not be delegated to another with impunity.
2. The experiment should be such as to yield fruitful results for the good of society, unprocurable by other methods or means of study, and not random and unnecessary in nature.
3. The experiment should be so designed and based on the results of animal experimentation and a knowledge of the natural history of the disease or other problem under study, that the anticipated results will justify the performance of the experiment.
4. The experiment should be so conducted as to avoid all unnecessary physical and mental suffering and injury.
5. No experiment should be conducted, where there is an a priori reason to believe that death or disabling injury will occur; except, perhaps, in those experiments where the experimental physicians also serve as subjects.
6. The degree of risk to be taken should never exceed that determined by the humanitarian importance of the problem to be solved by the experiment.
7. Proper preparations should be made and adequate facilities provided to protect the experimental subject against even remote possibilities of injury, disability, or death.
8. The experiment should be conducted only by scientifically qualified persons. The highest degree of skill and care should be required through all stages of the experiment of those who conduct or engage in the experiment.

9. During the course of the experiment, the human subject should be at liberty to bring the experiment to an end, if he has reached the physical or mental state, where continuation of the experiment seemed to him to be impossible.
10. During the course of the experiment, the scientist in charge must be prepared to terminate the experiment at any stage, if he has probable cause to believe, in the exercise of the good faith, superior skill and careful judgement required of him, that a continuation of the experiment is likely to result in injury, disability, or death to the experimental subject.
